### 3.4 Membership description

#### **EuroCham Myanmar Ordinary Membership**

A company can apply for Ordinary membership if:

- a) It is a legal entity duly established under the laws of any EU Member State, or a legal entity established under the laws of Myanmar being directly or indirectly controlled by an EU citizen or by an EU entity established under the laws of any EU Member State. Companies registered in other South -east Asian countries and representing EU-registered companies or European commercial interests are equally eligible; or
- b) It is a legal entity which conducts business, or promotes business, between the EU and Myanmar. In this case the company must submit an application to EuroCham and the Board will decide at its sole discretion whether such applicant is eligible for the membership.

If the applicant does not satisfy the criteria set forth under a) or b), it shall not be eligible as a EuroCham Member. However, it may be associated to EuroCham (without any voting right) on a case by case basis, when deemed appropriate by the Board.

#### **Yearly fees:**

Inscription: 700 € (Corporate) 350 € (SME)

Administrative costs (only first year) 100€/50€

#### **Indirect Membership**

European Companies already member of any bilateral chamber established in Myanmar will be considered as Indirect Members of EuroCham provided that the company's head quarter is legally located in the member state of the bilateral chamber. Membership confirmation from the concerned bilateral chamber needs to be attached to this membership form.

**EuroCham Myanmar Partner Membership**

A company can apply for Partner Membership if:

- a) It is a legal entity duly established under the laws of any EU Member State, or a legal entity established under the laws of Myanmar being directly or indirectly controlled by an EU citizen or by an EU entity established under the laws of any EU Member State. Companies registered in other South-east Asian countries and representing EU-registered companies or European commercial interests are equally eligible; or
- b) It is a legal entity which promotes EU interest such as selling European goods or European services in Myanmar. In this case the company must submit an application to EUROCHAM and the Board will decide at its sole discretion whether such applicant is eligible for the membership.

**Yearly fees** (Full Membership included) for inscription in 2018:

Platinum Partner: 6.000 €

Gold Partner: 3.000 €

Silver Partner: 1.500 €

Administrative costs (only first year) 100€/50€ (corporate/SMEs)

**3.5 Conditions**

<b>Validity of Membership</b>	Membership is intended for one year from day of payment.
<b>Membership activation</b>	Membership is activated upon receipt of duly compiled form and membership fees.
<b>Renewal</b>	Membership should be renewed one month maximum after membership expires.
<b>Termination</b>	EuroCham Myanmar has the right of termination on membership if the company a) provides false information; b) harms the image of EuroCham Myanmar; c) does not abide by the provisions of EuroCham Articles of Association and/or d) violates the laws of the Republic of the Union of Myanmar.
<b>Change of conditions</b>	EuroCham Myanmar reserves itself the right to change membership and partnership conditions. Members will be informed in advance via email.



**Logo**

Members have the right to use EuroCham Myanmar Logo. However:

- a) the use shall not harm the interests and activities of EuroCham Myanmar;
